

Madam/Sir,


With reference to the Ministry of Education letter No.8-11/2020-E.E.1 dated 23rd October, 2020 vide which DO letter dated 21st October, 2020 of Dept. of Pension & Pensioners' Welfare has been forwarded directing all the organisations to conduct a Nation-wide Pension Adalat in the month of December, 2020 for prompt resolution of pensioners' grievances, within the framework of extant policy/guidelines.

In view of the above, it has been decided by the Competent Authority of KVS that all the Regional Offices/ZIETs may conduct the Pension Adalat in the last week of December, 2020. It is advised that in the first instance, a Notice to this effect that pension Adalat will be conducted in the last week of December, 2020, should be published in the website of Regional Offices. It should also be mentioned in the said Notice that the aggrieved pensioners may submit their grievances to the Regional Offices/ZIETs through e-mail. Thereafter, the grievances received may be examined in your office and taken up in the Pension Adalat to be organized through **Digital Technology** only in the last week of December, 2020. It may be noted that only those grievances are to be taken up in the said Adalat which fall within the purview of extant Pension Policy/Rules/Guidelines etc. The family pension cases should be given Top Priority.

You are therefore, requested to circulate the content of this letter among all the KVs under your jurisdiction. Further, the copy of this letter should also be published on the official website of all the Regional Offices and KVs for information of pensioners under your jurisdiction. After conducting the said Adalat, the required information may be submitted to this office in the enclosed format by **4th January, 2020** through email (pensionkvshq@gmail.com) only for onward submission of the consolidated information by KVS(HQ) to Dept. of Pension & Pensioners' Welfare.
